1. ELIGIBILITY

- 1.1 The Cloud Server Free 30-Day Trial Offer ("Offer") is a Giacom initiative only and is not associated with any other company or other third party. Further details of the Offer are set out in section 2 of these Terms and Conditions below.
- 1.2 We are Giacom World Networks Limited (Giacom), whose registered office address is at Bridge Haven One, Saxon Way, Priory Park, Hessele, HU13 9PG.
- 1.3 The Offer is available to any company or individual which (A) has a signed current reseller agreement with us and (B) has a valid customer reference (MEX) number.
- 1.4 For the avoidance of doubt, the Offer is not available to anybody who has an agreement with us on an 'end user' basis.

2. THE OFFER

- 2.1 For the purposes of these Terms and Conditions:
 - (a) The "Offer" shall mean with effect from 28/10/2019, we are providing a 30-day free trial service as standard as part of the Cloud Server product;
 - (b) The Offer is limited to one activation per reseller with a verified MEX number, meaning you cannot request another 30-day free trial if you have already received one before.
 - (c) The Offer cannot be upgraded and does not include the Backup or VPN add-on SKU.
 - (d) Once the Offer has expired, you will automatically be charged for the lowest chargeable Entry Level SKU.
 - (e) If the Offer expires before your next bill, partial month usage will be automatically applied pro-rata on your next monthly bill.
 - (f) Deleting the service during the Offer period means you will not be charged. The service will cease at the point of deletion.

3. LIMITATION OF LIABILITY
